<b>Summary:</b>	<p>On 01 July 2022, Nokia Corporation, the Registry Operator for xn--jlq61u9w7b, notified ICANN that it wished to terminate the RA citing its own business needs. On 29 July 2022, ICANN made a preliminary determination that operation of the xn--jlq61u9w7b gTLD need not be transitioned to a successor Registry Operator.</p> <p>On 10 November 2022, after a 30-day period for comments by interested parties, ICANN made a Final Determination to terminate the xn--jlq61u9w7b Registry Agreement and revoke the TLD's delegation from the Root Zone.</p>
