

# gTLD Revocation Readiness Report

This Report summarizes the status of the steps required to request the revocation of a generic top-level domain (gTLD) subject to the terms outlined in the Registry Agreement and the Registry Transition Process. This Report was produced by the ICANN Global Domains Division Operations Team and documents the relevant requirements for Revocation.

<b>Summary:</b>	<p>On 5 July 2016, Connect West Pty. Ltd, the Registry Operator for .iinet, notified ICANN that it wished to terminate the RA citing its own business needs. On 16 November 2016, ICANN made a preliminary determination that operation of the .iinet gTLD need not be transitioned to a successor Registry Operator.</p> <p>On 17 December 2016, after a 30-day period for comments by interested parties, ICANN made a Final Determination to terminate the .iinet Registry Agreement and revoke the TLD's delegation from the Root Zone.</p>
