Summary:	On 12 March 2020, Symantec Corporation, the Registry Operator for .symantec, notified ICANN that it wished to terminate the RA citing its own business needs. On 30 April 2020, ICANN made a preliminary determination that operation of the .symantec gTLD need not be transitioned to a successor Registry Operator.
	On 18 June 2020, after a 30-day period for comments by interested parties, ICANN made a Final Determination to terminate the .symantec Registry Agreement and revoke the TLD's delegation from the Root Zone.
