
## gTLD Revocation Readiness Report for .passagens

## **REVOCATION READINESS SUMMARY | .PASSAGENS**

Summary:	On 12 January 2023, Travel Reservations SRL, the Registry Operator for .passagens, notified ICANN that it wished to terminate the RA citing its own business needs. On 18 April 2023, ICANN made a preliminary determination that operation of the .passagens gTLD need not be transitioned to a successor Registry Operator. On 31 May 2023, after a 30-day period for comments by interested parties, ICANN made a Final Determination to terminate the .passagens Registry Agreement and revoke the TLD's delegation from the Root Zone.
